

Supervisor Landi called the workshop to order at 7 PM. Present were Supervisor Landi, Councilman Hoffman, Councilman Nelson, Councilman Queipo, and Councilman Wells. Highway Superintendent Ed Moore, and Town Attorney Ashley Torre were also present.

Committee Reports

Councilman Hoffman asked if there were any updates on Hill Road.

Superintendent Moore said that the Town Engineer wants the Town to blast the mountain by the Sleights. The engineer says that everything being done on Hill Road is working to prevent the flooding. Councilman Hoffman made the motion, seconded by Councilman Nelson to have the Town purchase an AED (Automated External Defibrillator) for the Town Hall. All Approved.

Councilman Nelson reported that the Town Party is scheduled for October 16th.

Councilman Wells had nothing to report.

Councilman Queipo reported that the even though they have not heard from the Sheriff, he understands that there has been an increase in the Sheriff's patrol for the Town. The speaker system will be installed on Friday, August 26th. Crawford and Associates are writing a report on the Wintergreen Hill Bridge. Councilman Nelson made the motion, seconded by Councilman Queipo to have Crawford & Associates write and seek grants for the Wintergreen Hill project with their fee being up to \$1500. All Approved.

Supervisor Landi made the motion, seconded by Councilman Hoffman to move Local Law #2 Fees from the tabled items and into new business. All Approved.

Old Business

Councilman Nelson made the motion, seconded by Councilman Hoffman to purchase the material and the installation for a community library up to \$1500. All Approved. The community library will be installed in front of the Town Hall near the Court Clerk's parking space.

New Business

Councilman Nelson made the motion, seconded by Councilman Hoffman to adopt Local Law #2 – fees (see attached). A roll call vote was taken – Councilman Hoffman – yes; Councilman Nelson – yes; Councilman Queipo – yes; Councilman Wells – yes; Supervisor Landi – yes. Local Law #2 was adopted by a 5-0 vote. Supervisor Landi made the motion, seconded by Councilman Queipo to adopt Resolution # 32 – adoption of updated fee schedule including planning and zoning fees. All Approved

Councilman Hoffman made the motion, seconded by Councilman Queipo to appoint Ryan Polacco as the Budget Officer trainee starting at \$85.00 per month. All Approved.

Supervisor Landi made the motion, seconded by Councilman Queipo to pay the bills presented at today’s meeting. All Approved.

Councilman Queipo made the motion, seconded by Councilman Nelson to move for adjournment. All Approved. The meeting was adjourned at 7:35 PM.
